Registration Fee Information

The registration fee should be sent to the Finance Office and should be paid as soon as possible to ensure placement in the college but must be paid no later than registration day. Once this fee has been paid, new and returning students may then register for classes on a first-come, first-served basis. This fee will be reduced by 50% per semester if the student is taking 8 or fewer credits.

Move-in Day is August 28, 2024

New students are not allowed to move into the dorms prior to August 28. Campus Employees who are required to report to work early are the only exception.

Registration Day

All students (on-campus and off-campus) are required to attend the events on Registration Day (August 29). Students will be charged the \$175 late arrival fee if they do not complete the registration process on August 29.

Scholarship Programs

Academic Scholarship

Students who graduate as salutatorian or valedictorian from a Christian school may apply for this scholarship. Students who have a minimum composite score of 25 on the ACT (does not include writing score) or 1210 on the SAT (critical reading and math) will also qualify for this scholarship. An official copy of the ACT or SAT must be sent directly to the college. In order for the student to qualify for salutatorian or valedictorian portion of this scholarship, there must be at least five students in their graduating class. If the scholarship is awarded, the student will receive one semester's tuition free. This scholarsip cannot be combined with any other scholarship and is only available during a student's first semester of enrollment at GSBC. This scholarship is only available to undergraduate students who have completed high school within the past two years.

Alumni Children's Scholarships

Students who have a parent who graduated with a bachelor's degree from GSBC are eligilbe for this scholarship. A credit of \$500 will be applied to the first paymetn. This scholarship is only available during the student's first semester of enrollment at GSBC.

First GSBC Student Scholarship

The first student to attend GSBC from a particular church will receive a \$500 credit towards the first payment. If this applies to more than one student from the same church in one semester, all are eligible for this scholarship. This scholarship is only available during the student's first semester of enrollment at GSBC.

Freedom Scholarship

The tuition is reduced 50% for students whose major is pastoral theology, pastoral assistant or missions and who have served our country in active military duty and have been honorably discharged. If applying for this scholarship, students will need to provide a copy of the DD214 that was issued to them upon discharge. This scholarship cannot be combined with any other scholarship.

Full-Time Christian Service Scholarship

Students who have a parent in full-time Christian service are eligible for this scholarship. A credit of \$500 will be applied to the first payment. This scholarship is only available during the student's first semester of enrollment at GSBC.

Institution Scholarship

Scholarship discounts are available whenever five or more first time students from the same church (and/or church school) or Christian school enroll at Golden State Baptist College in the same semester. Scholarships start at \$500 (\$100 per student) and increase in individual increments of \$100 for each additional student in the group, up to a maximum of \$700 per student. The scholarship is nontransferable and must be used during registration towards the student's first semester expenses.

Missionary Scholarship

This applies to students whose parents are presently missionaries outside of the United States. The tuition is reduced by 50% for young ladies and 25% for young men. This scholarship cannot be combined with any other scholarship. If missionaries' children also qualify for the Academic Scholarship, they will be given the choice of which scholarship they would rather receive.

Pastors' Children's Scholarship

Pastors' children can apply for a pastors' children's scholarship. The tuition is reduced 50% for young ladies and 25% for young men. This scholarship cannot be combined with any other scholarship. If pastors' children also qualify for the Academic Scholarship, they will be given the choice of which scholarship they would rather receive. This scholarship is limited to the children of the Senior Pastor.
